The SEIS, was introduced in 2011 to run alongside the EIS and has similar objectives to the EIS, the main difference being that the SEIS is targeted at companies that are generally at an earlier stage in their development than EIS companies. As this is the case, the SEIS has some additional tax benefits, including 50% initial Income Tax Relief. With the government closing many tax “loopholes”, it is important to note that both the EIS and SEIS are non-aggressive schemes which successive governments have continued to support, and indeed improve on an ongoing basis. Indeed, in her Budget on 30<sup>th</sup> October 2024, the Chancellor specifically mentioned EIS and the government’s commitment to them. The reason for this continued support is that by investing in EIS and SEIS, investors are actually helping both small businesses and also the economy!
